BAR : TIMINGS AND PROCEDURES

Excise Rules and Regulations stipulate closure of all Bars at 12 Midnight, with the actual service being available up till half an hour prior to the actual time of closure. In view of these statutory requirements, your attention is drawn to the Club's Bars Timings and Regulation for strict adherence and compliance.

1. Bar Closing Time. 11:00PM on all days, except when notified on obtaining of the permission for late closing.

3. When Permission for Late Closing (1:00AM) Obtained – Applicable for Relevant Bar Only.

4. Implication of Bar Closing Time.

- (a) Bar to be closed and locked.
- (b) No Member or Guest should be drinking or in possession of any alcohol, anywhere in the premises after the Bar Closing Time.
- (c) The premises should be vacated.

5. On all days, except Fridays and Saturdays, the Club's premises should be vacated by 11:00 PM. On Fridays and Saturdays the Club's premises is to be vacated by 12 Midnight.

The staff has been instructed on strict compliance of the above timings and the Electricians have also been instructed to switch off all lights, A/Cs etc at the closing time of the Bars.

Bar premises being under CCTV Surveillance is a mandatory Excise and Police Department's requirement and its footage can be asked for by either of the Departments at any time. Any infringement will not only be liable to strict disciplinary action but will also result in the cancellation of the Club's Bar Licence.
